# **COMMISSIONS**

#### STANDARD ACCOUNT

No commissions are charged on transactions executed on our standard accounts. Our transaction fees are incorporated into the bid-offer spread for each standard account spread. Because we deal as principal, the prices we offer may not be the same as those in the underlying market and may be wider.



#### **PRO ACCOUNT**

Ox Securities Pty Ltd sets out the Commission of \$3.5 USD/lot for each currency pair on Foreign Exchange transactions (a one-way fee), and no commissions for Metals or CFDs transactions on PRO accounts.

#### **SWAP FEE**

The price of a Margin FX Contract and CFD contract reflect the value of one currency expressed in terms of a second currency. Our products do not create any right or obligation to receive the purchased currency. The foreign exchange markets by convention adjust the value of an open position to reflect the different interest rates applicable to the underlying currencies. If you have an open position in which you have taken the long or bought side in the high yielding currency then the value of the swap fee is basically in your favour to reflect the difference between the interest rates on the two currencies. In certain market conditions Ox Securities Pty Ltd may require clients to pay a Swap Fee where ordinarily they would have received a Swap Fee. For certain currency pairs, triple daily swaps are applied on Wednesday and Thursday. Swap Fees will be applied in your account currency.
